Little Gulls Beach & Forest School is a trading name of Rachel Stevens-Hall (also known as Rachel Stevens) and thereafter, in these terms and conditions 'Little Gulls Beach & Forest School' will be used for brevity to refer to 'Rachel Stevens-Hall trading as Little Gulls Beach & Forest School'.

Little Gulls Beach & Forest School is a group for children and their accompanying adults. In these terms and conditions 'you' will be used to refer to the adult making the booking and the adult accompanying the child at the Beach & Forest School session. It is acknowledged that this may not always be the same person. However, it is the responsibility of the adult making the booking and agreeing to the terms and conditions to inform any other accompanying adult of them. Beach and Forest School

By booking a place at Little Gulls Beach & Forest School, you recognise that the sessions take place in the natural environment and, therefore, have an element of personal risk and that, however unlikely, this risk can become a reality. It is important that you and your child listens to and act upon all safety instructions given by Little Gulls Beach & Forest School or any appointed staff.

Our Liability

By booking a place at Little Gulls Beach & Forest School, you agree that Little Gulls Beach & Forest School, any appointed staff and the landowners will not be liable now, or at any time in the future for any loss, expense, damage or claim you may have against them for any damage to you, your child or your property as a result of participation in a Beach & Forest School session. Little Gulls Beach & Forest School will only accept liability for physical injury to any client that is proven to result from direct negligence on the part of Little Gulls Beach & Forest School.

Variation of content by Little Gulls Beach & Forest School

Little Gulls Beach and Forest School sessions subject to natural forces and whilst every reasonable effort is made to comply with course content, Little Gulls Beach & Forest School reserves the right to vary or modify a course itinerary at short notice in order to take advantage of naturally prevailing conditions. You acknowledge that the information provided by Little Gulls Beach & Forest School is given to the best of our ability but, because of the variability of nature, it may be reasonable to alter or modify a course. In such circumstances, Little Gulls Beach & Forest School is not to liable for any losses consequential on such a change and that Little Gulls` liability is limited accordingly.

First Aid

In the event of an accident during a Little Gulls Beach & Forest School session, you agree to you or your child receiving immediate first aid by a qualified First Aider. We will ensure that there is always a member of staff fully trained in first aid and health and safety at each session.

Payment

Unless agreed in writing, payment for the the full term of Little Gulls Beach & Forest School is due at the time of booking. We are unable to hold or reserve places without payment.

Clothing

You should ensure that you and your child are wearing appropriate clothes and shoes for the Beach and Forest School session and please also bring a full spare set of clothes. We will provide all families with a recommended kit list on our website.

Unaccompanied Children

Little Gulls Beach & Forest School sessions are for children accompanied by their parent or carer, with a maximum of two children per adult. Unaccompanied children will not be allowed to take part in sessions. Additionally, we can not allow you to take part if you appear to be unfit to provide for the safety of your child or appear to be under the influence of alcohol or drugs.

Sickness

If you or your child develop an infectious illness you must not attend a Little Gulls Beach or Forest School sessions for a minimum of 48 hours after the illness, in compliance with Public Health England guidance. Unfortunately Little Gulls Beach & Forest School do not offer any refunds in the case of participant illness or any other unforeseen circumstances.

Cancellation by Little Gulls

In the event that a decision is made to cancel an activity you will be informed at the earliest opportunity to the contact email address given at the time of booking. Little Gulls Beach & Forest School cannot provide refunds for emergency closures as staff and premises will still need to be paid and such events are deemed to be force majeure. Little Gulls Beach & Forest School understand that it is inconvenient, and potentially costly, and will endeavour to do the reasonable best to make sure that this does not happen.

Termination of services

Little Gulls Beach & Forest School reserves the right to terminate any booking immediately in the event that any fees remain unpaid or where any of the terms and conditions are breached.
